## IPM statement

It is the goal of the Buckeye Union School District to implement IPM by focusing on long-term prevention or suppression of pests through accurate pest identification, by frequent monitoring for pest presence, by applying appropriate action levels, and by making the habitat less conducive to pests using sanitation and mechanical and physical controls. Pesticides that are effective will be used in a manner that minimizes risks to people, property, and the environment, and only after other options have been shown ineffective.

Our pest management objectives are to:

Promote a healthy environment through a combination of techniques such as: monitoring for pest presence and establishing treatment threshold levels, using nonchemical practices to make the habitat less conducive to pest development, improving sanitation, utilizing mechanical and physical controls, and utilizing the pesticides that pose the least possible hazard to people, property and the environment.

## IPM team

In addition to the IPM Coordinator, other individuals who are involved in purchasing, making IPM decisions, applying pesticides, and complying with the Healthy Schools Act requirements, include:

## Pest management contracting

- Pest management services are contracted to a licensed pest control business.  
Pest Control Business: Advanced Integrated Pest Management
- Prior to entering into a contract, the school district has confirmed that the pest control business understands the training requirement and other requirements of the Healthy Schools Act.

## Pest identification, monitoring and inspection

Pest Identification is done by: Advanced Integrated Pest Management

Monitoring and inspecting for pests and conditions that lead to pest problems are done regularly by Site Custodial Staff and results are communicated to the IPM Coordinator.

Specific information about monitoring and inspecting for pests, such as locations, times, or techniques include:

Custodial Staff- Report extent and location of pest problems encountered, inspect potential entry points of pests, report improper storage or housekeeping deficiencies, make corrective actions to deficiencies.  
Maintenance Supervisor- Inspect for structural or environmental deficiencies, take corrective actions.  
Advanced Integrated Pest Management- Inspect, log and report monthly findings, identify pests and locations, make recommendations and take corrective actions.

## Chemical pest management practices

## Submittal of pesticide use reports

- Reports of all pesticides applied by school district staff during the calendar year, except pesticides exempt<sup>1</sup> from HSA recordkeeping, are submitted to the Department of Pesticide Regulation at least annually, by January 30 of the following year, using the form provided at [www.cdpr.ca.gov/schoolipm](http://www.cdpr.ca.gov/schoolipm). (Education Code Section 16711)

<sup>1</sup> These pesticides are exempt from all Healthy Schools Act requirements, except the training requirement: 1) products used in self-contained baits or traps, 2) gels or pastes used as crack and crevice treatments, 3) antimicrobials, and 4) pesticides exempt from U.S. EPA registration. (Education Code Section 17610.5)
